

The Commission at its meeting held on 26.05.2023 has approved the recommendation of the Standing Committee on Autonomous Colleges to confer the autonomous status to **Nehru Institute of Technology, Coimbatore Tamilnadu affiliated to Anna University, Chennai** for a period of 10 years from the academic year 2023-2024 to 2032-2033 as per clause 7.5 of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023.



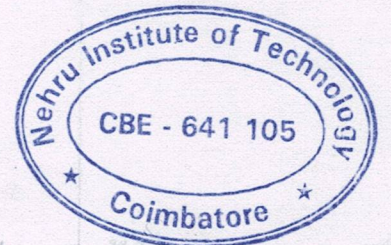

The college should apply to University Grants Commission for extension of autonomous status atleast three months before the completion of autonomy period.

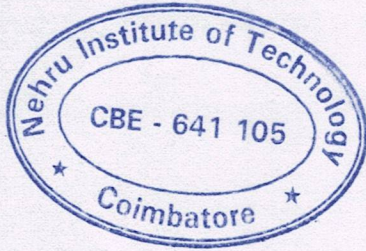

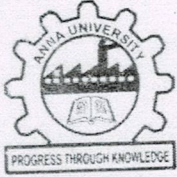
